### **The Role**

To plan and deliver suitable Advanced English with Global Studies lessons to British and International Summer School students, develop their cognitive skills and ensure a positive experience at the Summer School. To collaborate to deliver reflection sessions and support the Summer School programme while supporting the Summer School ethos.

### **Role Responsibilities**

- Plan and deliver suitable and appropriate Advanced English with Global Studies lessons to British and international students
- Write suitable lesson plans for each taught lesson and submit these by the set deadline
- Ensure a positive learning environment is cultivated
- Contribute to the Summer School Newsletter, showcasing projects, learning outcomes and student achievements by the set deadline
- Take class registers in every lesson as required
- Plan and deliver evening reflection sessions
- Work collaboratively to conduct project classes each Sunday
- Develop pre-visit and post-visit activities tailored to the educational excursions.
- Assess the risks and update them as needed.
- Attend teacher development sessions weekly
- Assist during meal times and with pastoral duties as needed
- Take part in staff meetings and assemblies as required
- Lead the safe transfer of students, as instructed by the management team
- Take part in excursions twice a week as required
- Encourage full student participation and enjoyment as far as possible and learner independence and skill development
- Be involved in the smooth integration of both British and international students
- Be aware of Child Protection issues and act accordingly as necessary, ensuring commitments to welfare are adhered to
- Take all the steps required to minimise any risk and report any concerns/feedback to your line manager
- Manage student behaviour in the boarding houses and address any incidents that may arise between students to provide a safe and harmonious living community
- Manage student behaviour to create a safe, inclusive environment where everyone can confidently express their opinions and thrive

- Help prepare and conclude the course, setting up as required
- Complete incident forms as necessary, submit these as instructed, and report to your line manager
- Attend Staff Induction and complete CPD courses as required
- Carry out other ad-hoc duties as requested
