

**Job description for a Learning Support Assistant  
Grade 6**

**Hours:** The post will be for 18 hours per week – 8.30am-3.15pm, three days per week, Wednesday to Friday. This working pattern will include a 15-minute unpaid morning break and a 30-minute unpaid lunch break each day – by arrangement with line manager (staff room is available)

<b>JOB DESCRIPTION: LEARNING SUPPORT ASSISTANT</b>
<b>JOB PURPOSE:</b> To assist in the support and inclusion of students with Special Educational Needs within a mainstream school.
<b>OBJECTIVES:</b> <ul style="list-style-type: none"> <li>• To ensure SEN students have adapted opportunities to achieve their academic and personal development targets.</li> </ul>
<b>MAJOR AREAS OF RESPONSIBILITY:</b> <p>A. Pupil Support – Develop an understanding of the specific needs of students on the register and aid each student to learn as effectively as possible</p> <p>B. Teacher support – Assist the teacher in the development of a suitable programme for support.</p> <p>C. Department support – Work closely with the SENCo to implement approaches which enable individual pupils to make progress, to recognise and celebrate that progress and to know what the next learning steps need to be.</p>
<b>KEY TASKS:</b> <p>A1. Support students in the classroom.</p> <p>A2. Clarify or re-explain instructions and criteria for success.</p> <p>A3. Motivate students and reinforce past successes to build confidence.</p> <p>A4. Assist in areas that require development, eg language, behaviour, reading, spelling, fine motor skills, gross motor skills, physiotherapy exercises and social skills.</p> <p>A5. Establish a supportive and respectful relationship with the students.</p> <p>A6. Encourage inclusion and acceptance of the student.</p> <p>A7. Record the progress and support the achievement of targets</p> <p>A8. Work on a one-to-one or a small group basis with students with learning difficulties planning and delivering interventions to improve their attainment.</p> <p>B1. Assist the teacher by shared planning and development of suitable resources so that students can access the learning of the lesson.</p> <p>B2. Develop a system with the class teacher of sharing the student's learning progress</p> <p>B3. Participate in the evaluation of the support</p> <p>B4. Seek opportunities for students to undertake group work and facilitate effective independent work and collaboration with peers.</p> <p>C1. Work closely with SENCo to implement approaches which enable individual pupils to make progress within a mainstream setting.</p> <p>C2. Liaise with SENCo concerning progress and wellbeing.</p> <p>C3. Create targets for students through discussion.</p>
<b>OUTCOMES</b> The outcomes that are associated with this role are to work as part of the Learning Support team who: <ul style="list-style-type: none"> <li>○ Are consistent in their practice</li> <li>○ Share good practice with other team members</li> </ul>

- Act as role models for all learners

The outcomes associated with the specific role are:

- Effective communication
- An individual and team belief that all students can learn and develop
- An ethos where problems are minimised
- Effective teamwork where everyone is treated with dignity and respect
- Students feel confident and are included
- Students with specific literacy challenges make progress.
