Main Purpose of the Role

To provide strategic and operational leadership as the Headteacher of St Augustine's Secondary School, while holding directorial accountability for educational standards across the Trust's three coastal primary schools. They will work with the Chief Standards Officer for Secondary standards at St Mary's College to align the school's achievement with that of the sister school. Using the exceptional practice and resources demonstrated there, to improve outcomes at an accelerated pace.

The postholder will be a practising Catholic, ensuring that Christ is at the Centre of our schools.

Working together with the Trust Director of Chaplaincy and the Primary RE Coordinator, you will lead the Catholic Life and Mission and RE, ensuring that all adults act as role models with the knowledge to spiritually awaken others.

Principal Accountabilities

1. Catholic Life, Mission & Religious Education

- Secure the Catholic ethos of the schools, ensuring that the glory of God is reflected in every student becoming fully alive.
- Collaborate intimately with the Trust Director of Chaplaincy and Chaplaincy teams to target young people on the margins and ensure all experience Christ.
- Oversee the quality of Religious Education and Catholic Christian Worship, ensuring it is exemplary and aligns with the Prayer and Liturgy document and the RED.



- Along with the headteachers across the Trust, ensure that Catholic Social Teaching is threaded effectively through the curriculum offer.

2. Strategic Leadership & Standards (Coastal Hub)

- Deliver the Trust's Core Offer to the schools in collaboration with and under direction of the CEO, the Chief Standards Officer for Secondary and the Chief Standards Officer for Primary.
- Act as the lead professional for Standards across the coastal schools, meeting the Trust's high expectations for achievement and improving pupil outcomes.
- Establish a culture where "essential for some is beneficial for all," ensuring inclusion is at the heart of all pedagogical decision-making.
- Analyse performance data across the hub to identify needs early and deploy specialist support effectively.
- Ensure transition between the coastal primary phases and St Augustine's is seamless, supporting the immediate success of pupils upon entry.

3. Quality of Education & Pedagogy

- Embed "highly intentional teaching strategies" across St Augustine's and the primary schools, ensuring teaching is adaptive so every child makes progress regardless of need.
- Champion the Trust's ambition that Reading is the core focus; ensuring fluency is a high priority to enable access to the wider curriculum.
- Champion a curriculum where foundational knowledge is paramount, specifically ensuring that transcriptional skills are taught with rigour so that students master automaticity and write with excellence.
- Ensure Oracy is embedded in classrooms so that quality talk is seen as an integral part of teaching and learning.
- Curate a curriculum that includes cultural experiences to ensure pupils gain the knowledge needed for long-term success.

4. Inclusion & Behaviour

- Uphold the principle that all are equally deserving of respect and protection and that children, regardless of need, are welcome in our schools.



- Working with the Director of Inclusion ensure all staff have knowledge and understanding of neurodiversity and the tools to ensure pupil success.
- Foster a climate where expectations in behaviour result in high standards of academic excellence and where pupils are not excluded from our schools.

5. Leadership of Staff & Organisation

- Build strong, nurturing relationships with staff, modelling the belief that "educating is not a profession but an attitude".
- Promote psychological safety in teams through courageous conversations.
- Collaborate with our Teaching School Hub to strengthen initial teacher training and staff and leadership development pathways.
