ACCOUNTABLE TO	The Teaching Assistant will report directly to the Head of Learning Support/Assistant Headteacher and will work under the direction of the Headteacher and other members of the School Senior Leadership Team on specific aspects of the role.

JOB PURPOSE	<p>The Teaching Assistant is responsible for:</p> <ul style="list-style-type: none"> Supporting the education, personal and social development of students with additional needs under the teacher's clear guidance. Working with individuals and small groups and establish positive relationships with students and parents.
MAIN DUTIES / KEY TASKS	<ul style="list-style-type: none"> Implement programmes of structured learning activities and to assist individuals/group of students under the clear guidance of the teacher. Support students with their individual needs and implement related personal programmes either in the classroom, in small groups or 1:1. Encourage students to develop their independence. Assist in the devising of student's individual targets, personal support plans and contribute to their monitoring and review. Assist in the delivery of educational and vocational programmes and assist in transition. Support the promotion of positive relationships with parents, carers and outside agencies. Assist in the production of learning resources and to provide information to the class teacher to assist in the planning of work programmes Administer routine tests and assist in the invigilation of exams. Undertake break and lunch time duties within working hours as required. Be aware of the confidential nature of issues related to home/student/teacher/school work. Ensure all students have equal access to opportunities to learn and develop. Participate in training and other learning activities and performance development as required. Ensure all students have equal access to opportunities to learn and develop.
