JOB PURPOSE
To implement pastoral support, contributing to the monitoring overall progress and development of individual pupils, ensuring a consistent approach across the academy.
MAIN DUTIES AND RESPONSIBILITIES
<ul style="list-style-type: none">• To carry out assessments of students and their families/carers identifying, signposting, and referring to support services where required• To contribute to the planning of interventions for identified students ensuring students are able to effectively access learning• Ensure accurate records for students and their families are maintained, clearly identifying support plans and interventions required• Provide guidance, advice and support to colleagues, students and their families or carers to ensure appropriate interventions and protection is provided• Provide feedback to support the development of academy policies and procedures relating to Child Protection, Safeguarding, Behaviour and Attendance• Contribute to the organisation and running of group interventions with identified groups of students and their families or carers focussing on improving behaviour both inside and outside of the Academy• Work in conjunction with external agencies to ensure that a well-rounded support is provided to students and their families/carers• Create and present progress reports for students to leaders and external agencies, identifying student needs, intervention plans and support services highlighting student progress, behaviour, and attainment• To be responsible for data analysis, data input and other administrative tasks as directed related to pastoral invention, including preparation of relevant documents, data and information for attendance at meetings, case conferences and reviews
Safeguarding Statement
