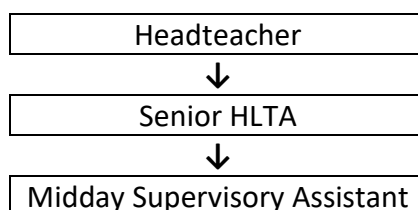

PURPOSE OF POST: Responsible to the Senior Higher Level Teaching Assistant, and under the general direction of the Headteacher, during the midday break, ensure the safety and general welfare and proper conduct of the pupils during this period.

1.	Supervise pupils immediately before, during and after the midday break. This includes pupils who have a school meal as well as pupils who bring their own food.	55
2.	Assist pupils as required with toileting and personal hygiene (under the general direction of the Senior Midday Supervisor).	5
3.	Assist with the lifting and handling of non-ambulant pupils in conjunction with other staff members, making use of mechanical aids as necessary.	2
4.	Encourage and assist pupils in eating, cutting up food, providing guidance on the proper use of cutlery. Assist with the clearance of spillages as necessary.	10
5.	Assist pupils in carrying/transporting trays to the tables and returning crockery to the food counter.	10

CONTEXT:
