

## Class Teacher

(for teachers primarily working in a SEND Unit or Provision, or for responsibility for the teaching of pupils with SEND)

### Job purpose including main duties and responsibilities

In addition to the General Professional duties set out in the School Teachers' Pay and Conditions Document the following duties are attached to the post of Class Teacher.

#### Main objectives of the post:

#### General Responsibility

1. To be the class teacher of the allocated class or group of pupils, displaying a high level of professional ability. To be responsible for the education and welfare of this group of children in accordance with the Terms and Conditions of Employment, having due regard to the requirements of the National Curriculum, EYFS Curriculum and Academy policies.
2. To be responsible for planning, assessing and evaluating the learning and progress of every child and keeping appropriate records, including those with SEND. Pupil progress will be tracked and planning will remove barriers to learning and target learning gaps, including planning for high quality intervention programmes.
3. Adapt teaching approaches, resources, environment and provision appropriately for a range of pupils' needs, ages and development stages, including designing and delivering structured intervention programmes linked to the both agreed curriculum and individual pupils' needs, linked to any relevant EHCP.
4. To ensure that a high standard of physical and emotional care for all children is maintained, including assisting pupils with personal care and hygiene which may include using the toilet, changing, washing and administering medication if required.
5. Work with leaders and colleagues who have a responsibility for SEND to contribute to provision mapping, target setting, reviews and EHCPs.
6. To maintain an effective working environment which support individual pupils' needs, linked to any relevant EHCP, and displays children's learning and relevant resource material attractively.
7. To provide advice and support to parents and carers about their child's development.
8. To ensure every effort is made to develop and maintain good relationships and professional communication with parents and carers, other professionals, and the local community.
9. To plan for educational enrichment activities and to assist with the running of extra-curricular activities, where appropriate, in conjunction with other members of staff.
10. To share in the responsibility for the safeguarding, well-being and inclusion of all pupils, including those with SEND. All staff have corporate responsibility for all children.
11. To follow the Academy and School Behaviour Policy as agreed by staff and governors to ensure good conduct and behaviour of all the children in school.

12. To successfully lead a curriculum subject or area of learning, depending on experience and the needs of the school.
13. To establish links with, and work collaboratively with, and taking advice from (where applicable), community and internal/external agencies e.g. pre-school settings, speech and language therapists.
14. To work effectively with colleagues, including planning for the deployment of educational support staff.
15. To undertake relevant training and professional development in line with the school or Trust development plan.
