## **Main Purpose of the role**

- To provide Speech and Language therapy to pupils with communication needs in association with and in addition to Autism Spectrum Disorders, Forest Bridge School and work collaboratively with the class teacher, ABA supervisor and other professionals
- Provide assessment for current and prospective pupils as needed
- To contribute to training of professional staff and others as required
- All written documents as needed at a professional standard
- To ensure the service is provided in close collaboration with education staff and other professionals to meet the needs of the pupil
- To work in support of the vision and ethos of the school, in line with teaching and ABA practices.

## **Role summary**

The Specialist Speech and Language Therapist post provides for pupils diagnosed with Autism Spectrum Conditions, some with co-morbidities including seizures, ADHD and mental health needs.

Duties include the delivery of therapy intervention ensuring that the speech, language and communication programmes are integral to the pupils' educational and developmental programme.

## **Clinical responsibilities:**

- Assessing and diagnosing a wide range of communication disorders
- To report and discuss with the SALT Lead the progress of the caseloads
- Planning appropriate therapeutic intervention in collaboration with the therapies team and the wider education team
- Delivering group and individual therapy as required
- Providing advice and therapy programmes to education staff, parents and other health professionals
- Managing parental and/or school anxieties regarding intervention and prognosis
- Evaluating treatment outcomes; Adapting SaLT provision according to pupils' needs and progress
- To use a range of AAC tools and PECS to enhance the ABA strategies and provide support to the staff team in the usage of the tools.
- To maintain an up to date knowledge of new techniques and development within the field of AAC and Speech and Language development

# **JOB DESCRIPTION**

## **Professional Responsibility:**

- To demonstrate clinical effectiveness by use of evidence-based practice and outcome measures
- To be responsible for managing own time appropriately and prioritise tasks accordingly in order to carry out clinically related administrative duties, relevant to the caseload and operation of the school
- To manage a complex caseload whilst recognising own professional boundaries and access supervision, advice and support when necessary
- To work closely with relevant parties about individual students and practically demonstrate therapeutic approaches where appropriate
- To work collaboratively with colleagues to support service delivery in line with the school's policy and ethos
- To care for and maintain equipment ensuring standards of infection control and safety are maintained
- To provide relevant in-service training to school staff and parents, via presentations, talks and career evenings on topics related to the role of the speech and language therapist, communication and therapy. To reflect on and evaluate training provided
- To collect clinical data and write reports for Annual Reviews
- To be responsible for maintaining up to date and accurate case notes in line with professional standards and school policies
