To assess student progress and promote achievement. To model and foster good relationships in school based on respect and integrity.

High Standards of Teaching and Learning	To prepare lessons for classes including , where appropriate, BTEC, GCSE and A Level based on a sound understanding of the learning needs of every student. To have knowledge of the learners' individual needs including those who are high attaining or have SEN and plan accordingly. To liaise with the Inclusion team as required. To assess and monitor student learning including giving verbal and whole-class feedback which facilitates student progress. To follow schemes of work agreed within the department and make a contribution to their development. To establish and maintain a positive classroom climate which supports the achievement of every student.
