Main Purpose of Job

The Behaviour Manager will contribute to the operational leadership of the school, ensuring effective behaviour systems and procedures are consistently implemented.

The postholder will ensure the highest level of behaviour care is provided to every student.

Duties and Responsibilities

Behaviour Systems & Support

1. Manage and support behaviour support processes, including supervision of the reflection/reset room and undertaking behavioural interventions with cohorts of students.
2. Identify and regularly monitor the behaviour, attendance and punctuality, attainment and progress of student groups and oversee support and interventions.
3. Produce reports as required on student attainment, progress and behaviour.

4. Liaise with appropriate personnel regarding support for student progress and wellbeing, e.g. school staff, parents/carers, outside agencies, governors etc. as appropriate.
5. Foster effective relationships with the parents/carers of the students and communicate regularly with them.
6. Participate actively throughout the network, by attending relevant meetings, and, as appropriate, delivering network-wide training and initiatives.

Leadership

1. Contribute to the strategic development, implementing and evaluating systems, policies and procedures relating to the behaviour and pastoral provision.
2. Plan tutorial programmes, supporting tutors in its resourcing and monitoring its delivery.
3. Support the behaviour team for a cohort of students and lead assemblies.
4. Support on developing and enhancing their practice, ensuring that their CPD needs are met, so that the highest level of behaviour care is provided to every student.
5. Lead colleagues in formulating aims, objectives and strategic plans for the team.
6. Effectively manage a budget, physical resources, stock and subject accommodation according to the academy's procedures in order to maximise attainment levels and maintain an environment conducive to learning.

Other

1. Use strategies to assist in behaviour management and to support students in their learning objectives.
2. Use specialist skills to meet the intellectual, physical, social and emotional needs of students.
3. To contribute to the overall ethos and aims of the school.
4. To be aware of, and work in accordance with the school's safeguarding procedures, and to raise any concerns relating to safeguarding.
