- Ensure effective use of formative and summative assessment to inform planning and interventions.
- Provide feedback to students that moves learning forward.
- Create a positive learning environment and make effective use of available resources.
- Ensure homework is set and monitored according to department policy.
- Act as a form tutor to a group of students, offer pastoral support, deliver the agreed tutor programme and PSHE programme (if required).

### **General Duties and Responsibilities**

- To care for the teaching areas and resources used in the school and ensure attention to Health and Safety requirements
