Post Title:	Assistant Principal (Secondary)

ROLE OVERVIEW:

The Assistant Principal should be prepared to lead on aspects of areas such as curriculum development, personal development, monitoring of standards and teacher effectiveness, tracking and analysis of results/data, behaviour management, staff development, training and induction. As a member of the senior leadership team, the Assistant Principal will also be centrally involved in the overall leadership and management of the academy and will help to establish an academy culture that is both nurturing and rigorous.

KEY ACCOUNTABILITIES:

LEADERSHIP AND MANAGEMENT

- To contribute to the development of the curriculum across the academy. Taking responsibility for specific aspects of the academy curriculum.
- Support the training and development of teaching staff so as to improve the quality of teaching.
- To contribute to the continual improvement of the academy culture curriculum and student personal development.
- To lead on strategies at Key Stage 3 to ensure all students make the necessary progress in line with their starting point.
- To contribute to the Academy's CPD programme, including co-ordinating training programmes, delivering INSET and working with individuals and teams in a variety of professional development activities.
- To line manage a faculty and Year Team within the academy in order to raise standards.
- To oversee the coordination and verification of external visits and act as part of the Educational Visits team.
- To play a major role in setting and establishing future strategy for the academy.
- To share responsibility for the management of the academy and to contribute to the consultative and decision-making process.
- To fully support whole academy policy decisions, contribute to their initiation and sustain their implementation and review.
- To inspire, motivate and influence staff and students, taking a leading role in maintaining the highest standards of teaching, learning and student discipline.
- To provide an excellent role model for all members of staff and students in all aspects of academy life.
- To be an exemplar of all academy policies and practices.
- To actively promote the aims of the Academy and to offer support and guidance to colleagues.
- To assist the Principal in academy self-review and evaluation and in the effective planning and management of academy resources to secure improvements.
- To maintain an informed view of standards and the quality of education across the Academy.
- To ensure that the academy QA policy and calendar are implemented and any subsequent follow up is actioned.
- To provide a strong and empathetic approach in order to ensure an inclusive and supportive environment to enable students and staff to work creatively and successfully.
- To be mindful of the wellbeing and mental health of students and staff.

- To maintain a presence around the Academy to ensure the highest standards of behaviour and to contribute to the overview and review of student behaviour.
 - To be active in issues of staff and student welfare and support.
 - To maintain the Academy culture and ethos that is utterly committed to delivering high standards of education.

- To be personally accountable for delivering services efficiently, within budget and to implement any approved savings and investment allocated to the service area.
