JOB DESCRIPTION

Corporate Responsibilities

- Assist arrangement for the effective maintenance and security of the site, compliant with legislation and regulations, supporting students to achieve top 10% outcome in a remarkable learning environment
- Responsible for the day to day grounds maintenance ranging from the general up-keep of the garden and landscaped areas of the school through to the maintenance of the grass sports pitches and facilities, including the synthetic pitch
- Ensure probity, propriety and adherence to the Nolan Principles both in your personal conduct and throughout the Trust
- Adhere to the principles of alignment in the One Trust Contract
- Contribute to a culture of relentless improvement, where feedback is a gift
- Comply with policies and procedures relating to Child Protection and promoting the well-being of children; being hyper-vigilant in all interactions with pupils and adults and reporting any concerns or suspicions, no matter how small, to the Designated Safeguarding Lead (Pupils) / Headteacher (Staff)
- Comply with all policies, procedures, working practices and regulations, in particular, Child Protection, Equality and Diversity, Health and Safety, Confidentiality, Data Protection, Financial Regulations in line with our Scheme of Delegation

Key Duties and Responsibilities

- Assist in ensuring that all areas of schools building and grounds are clean and ready for use daily and operation of heating and utility systems
- Assist with security arrangement and maintaining a good state of repair and appearance, reporting concerns to the Site Manager
- Maintenance of the grass pitches including cutting, spiking, rolling, re-seeding and marking out. Undertake all preparatory and cultivation work to main safe and quality playing surfaces
- Surface treatment of the synthetic pitch including marking out
- Upkeep of the gardens, borders and hedges
- Maintenance of all pathways and paved areas and keeping the grounds litter free
- Ensuring the grounds are accessible during winter months, snow ploughing and salt spreading as and when required
- Designated key-holder with responsibility for opening and closing school or emergency callouts as directed
- Support arrangement for an effective planned preventative maintenance programme and provide site services to colleagues
- Carry out general maintenance and minor repair work with adherence to health and safety regulations
- Support arrangement for evacuation, invacuation and lockdown procedures
- Monitor supplies ensuring that there is adequate stock to meet the needs of the school in line with financial procedures.
- Move and store supplies and waste as required
- Communicate effectively with colleagues to provide information or support activity in relation to school and site requirements
- Liaise with of contractors, ensuring concerns are reported in line with Trust procedures
- Support implementation of site changes / projects as directed
- Be aware of and comply with policies and procedures relating to child protection, health, safety and security, confidentiality, and data protection, reporting all concerns to an appropriate person.
- Attend and participate in relevant meetings as required.
- Participate in training and other learning activities and performance development as required.
- Maintain accurate records using relevant systems in line with policy and records management procedures
- Provide out of hours and emergency site cover or support for colleagues

- Assist with the supervision and welfare of pupils, contributing to effective behaviour management in school
