<b>TEACHING AND MANAGING STUDENT LEARNING</b>	<ul style="list-style-type: none"> <li>Ensure effective teaching of whole classes, groups and individuals so that teaching objectives are met, momentum and challenge are maintained, and best use is made of teaching time.</li> <li>Use engaging teaching methods, including stimulating students' intellectual curiosity, effective questioning and response, clear presentation and good use of resources.</li> <li>Set high expectations for students' behaviour, establishing and maintaining a good standard of discipline through well-focused teaching and through positive and productive relationships.</li> </ul>

<p><b>PLANNING AND SETTING EXPECTATIONS/STUDENT ACHIEVEMENT</b></p>	<ul style="list-style-type: none"> <li>• Identify clear teaching objectives, content, lesson structures and sequences appropriate to the subject matter and the students being taught.</li> <li>• Set appropriate and demanding expectations for students' learning and motivation. Set clear targets for students' learning, building on prior attainment.</li> <li>• Identify students who have special educational needs, and know where to get help in order to give positive and targeted support. Implement and keep records on Individual Education Plans (IEPs).</li> </ul>
<p><b>ASSESSMENT AND EVALUATION</b></p>	<ul style="list-style-type: none"> <li>• Assess how well learning objectives have been achieved and use this assessment for future teaching.</li> <li>• Mark and monitor students' class and homework providing constructive oral and written feedback, setting targets for students' progress.</li> <li>• Understand the demands expected of students in relation to the National Curriculum, KS4 and post-16 courses (as directed by school).</li> </ul>
<p><b>RELATIONSHIP WITH PARENTS AND THE WIDER COMMUNITY</b></p>	<ul style="list-style-type: none"> <li>• Prepare and present informative reports to parents.</li> <li>• Provide opportunities to develop students' understanding by relating their learning to real and work-related examples, recognising that learning takes place outside the school context.</li> <li>• As appropriate, liaise with agencies responsible for students' welfare.</li> </ul>
<p><b>MANAGE OWN PERFORMANCE AND DEVELOPMENT</b></p>	<ul style="list-style-type: none"> <li>• Take responsibility for their own professional development and to keep up to date with research and developments in pedagogy and in the subjects they teach.</li> <li>• Share corporate responsibility for the implementation of school policies and practices.</li> <li>• Set a good example to the students in their presentation and their personal conduct.</li> <li>• Evaluate their own teaching critically and use this to improve their effectiveness.</li> </ul>
