Join our team and we will work together to deliver 'excellence for all', enabling all pupils and staff to thrive and be successful. If this excites you; we want to hear from you!

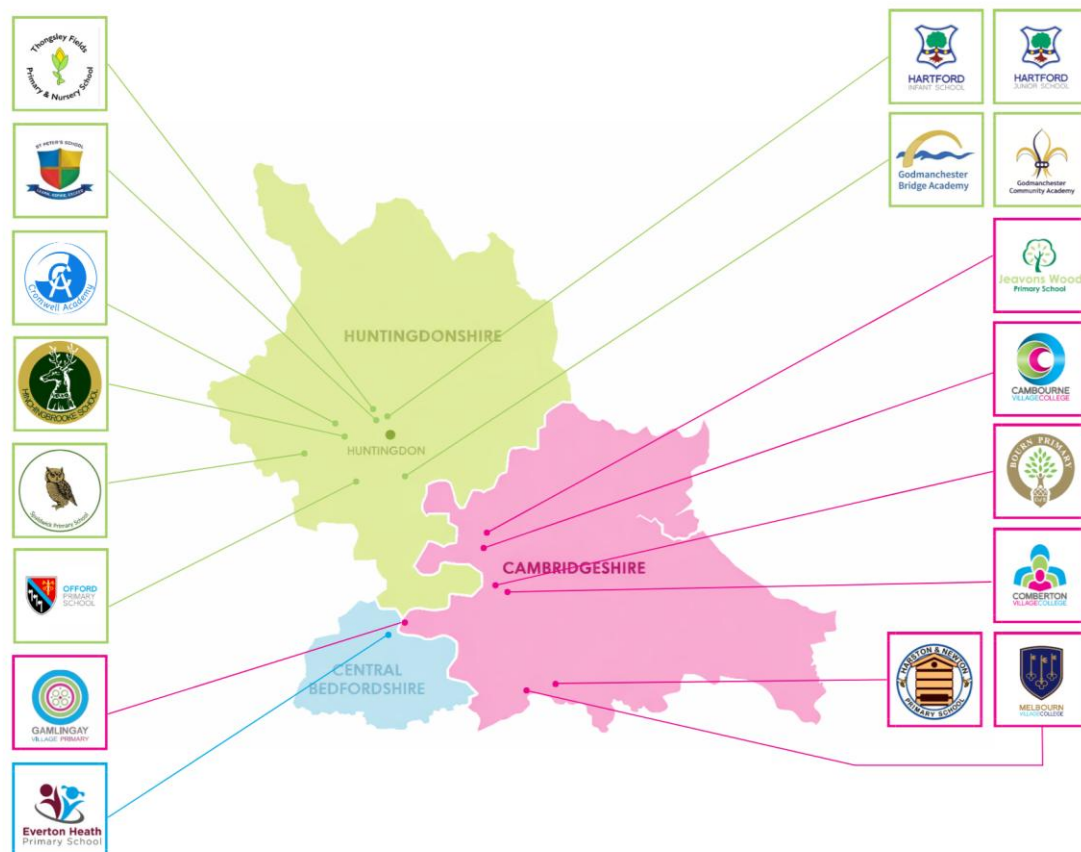

Our primary schools are Cromwell Academy, Everton Heath Primary School (just inside Bedfordshire), Gamlingay Village Primary, Godmanchester Bridge Academy, Godmanchester Community Academy, Jeavons Wood Primary School, Offord Primary School, Hartford Infant and Pre-School, Hartford Junior School, Harston and Newton Primary School, Spaldwick Primary School and Thongsley Fields Primary and Nursery School. The successful candidate will lead a department of 3 full-time & 1 part-time teacher and a technician with a range of expertise and skills. The department has 5 workshops, a dedicated IT suite, along with a range of industry standard machinery including large laser cutter, CNC milling machine, as well as 4 3D printers.

DT is a popular subject at GCSE with over 80 students per year opting to take it; numbers taking the subject at KS5 have been increasing and we have a higher proportion of girls than average taking the subject. The department supports students on to college, apprenticeships and Design Degrees at University. The department has links with local businesses and has previously entered a range of competitions, which is an area we are looking to expand on.

We welcome applications from candidates who have the drive and passion to share high quality and innovative practice in the classroom, and lead Curriculum development. The successful candidate will be student and staff focused and passionate about sharing their love of DT with our diverse and inclusive student body.

Hinchingsbrooke School is a 'Good' school (Ofsted November 2021). It is oversubscribed and boasts a growing and very successful sixth form. Hinchingsbrooke School is also an outstandingly beautiful school. Set in acres of grounds, Hinchingsbrooke House was formerly the family home of the Cromwell family and the Earls of Sandwich. 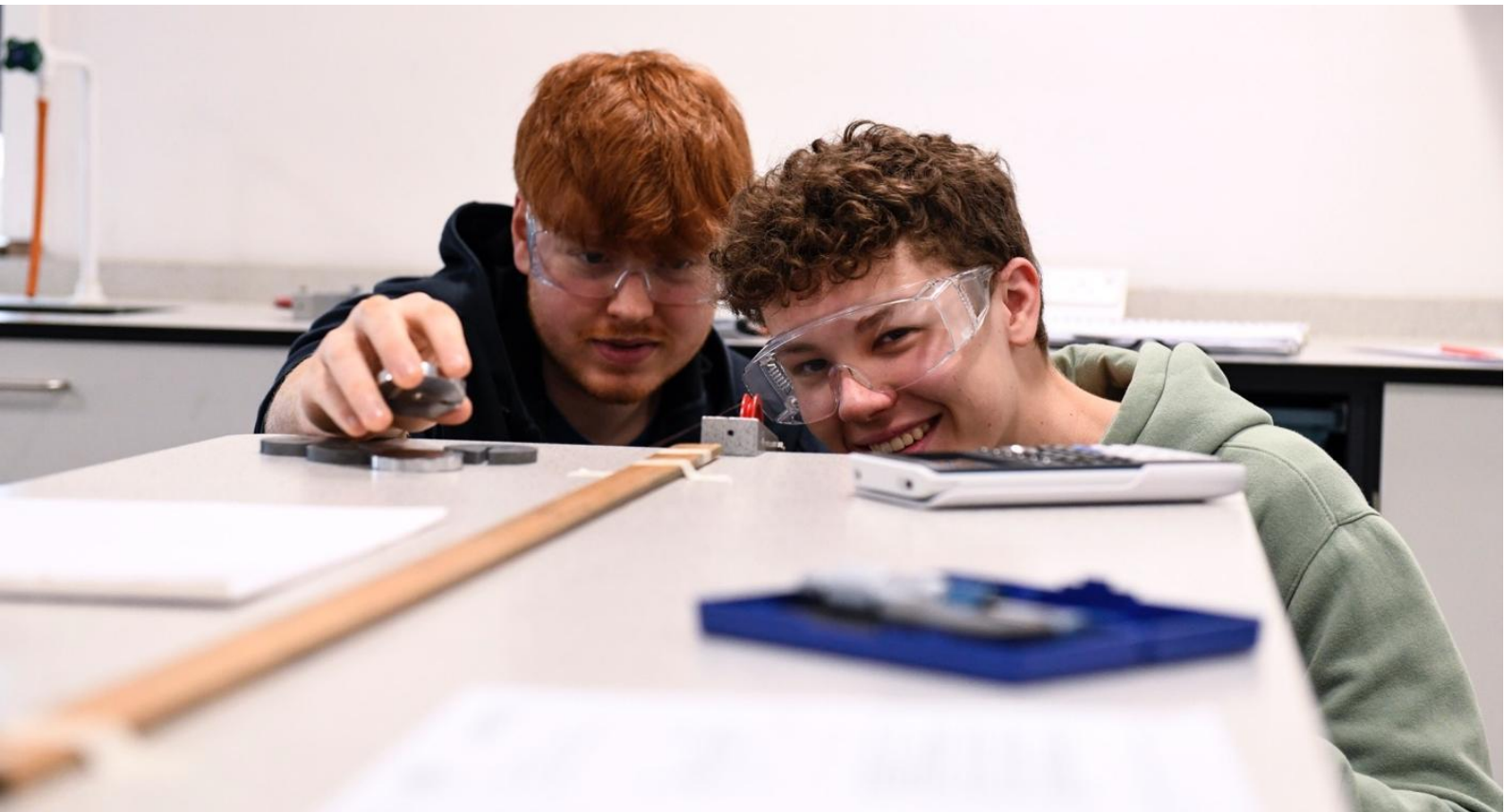
