Principal Accountabilities/ Responsibilities	 Strategic and Financial Leadership Partner with the Head and Governing Body to ensure the School's financial sustainability and to drive long-term strategic planning. Lead all aspects of the School's financial management, including budgeting, forecasting, reporting, and compliance with Trust and statutory regulations. Produce timely management reports and financial analyses for the Head, Leadership Team, and Governors. Oversee the preparation of the annual budget and ensure robust financial controls are in place. Work closely with the Trust Chief Financial Officer and finance team to ensure consistency of standards and alignment with Trust financial policies. Drive financial efficiency and value for money without compromising educational quality. Lead on commercial and income-generating activities, including lettings and third-party contracts. Work with the Harpur Trust Fees team to manage debtors and the process for recovery of outstanding debts and liaising with parents, where necessary.

- Oversee property management, including staff accommodation and lettings.
- Maintain adequate insurance and ensure the effective handling of data protection, risk, and compliance matters. With support from the Trust office, handle any data breaches or subject access requests.
- Support the School's sustainability objectives through efficient resource and energy management.

People Leadership and Management

- Lead and develop a multi-disciplinary team of professional services staff.
- Ensure effective recruitment, appraisal, professional development and performance management.
- Promote a cohesive, supportive, and high-performing culture across all teams.
- Work collaboratively with Harpur Trust colleagues to share best practice and contribute to cross-Trust initiatives.
- Act as a visible, trusted partner to the Head, Leadership Team and Governing Body.
