This Policy applies to all Thomas's Schools, including Thomas's Kindergarten. Thomas's London Day Schools operates as a united group of schools with a similar ethos and values and as such is referred to as a singular body.

This Policy should be read in conjunction with the Safer Recruitment Policy and Data Protection Policy.

## **1. INTRODUCTION**

- 1.1. This notice explains what personal data (information) we will hold about you, how we collect it, and how we will use and may share information about you during the application process. It applies to all individuals applying for a position at the Group, including positions as a member of staff (full time or part time), contractors, workers, governors, volunteers and peripatetic staff. It also applies to individuals we will contact in order to find out more about our job applicants, including referees, or those that are provided by job applicants as an emergency contact.
- 1.2. You are being sent a copy of this privacy notice because you are applying to work with us (whether as an employee, worker, or contractor). We are required to notify you of this information under data protection legislation. Please ensure that you read this notice (sometimes referred to as a 'privacy notice') and any other similar notice we may provide to you from time to time when we collect or process personal information about you.

## **2. WHO COLLECTS THE INFORMATION**

- 2.1. Thomas's London Day Schools ('Group') is a 'controller' in relation to personal data and gathers and uses certain information about you. This means that we are responsible for deciding how we hold and use your personal information.
- 2.2. Thomas's has appointed the Head of Compliance as Data Protection Officer (DPO) to deal with all your requests and enquiries concerning the Group's uses of your personal data (see section on Your Rights below) and endeavour to ensure that all personal data is processed in compliance with this policy and Data Protection Law. ## **3. DATA PROTECTION PRINCIPLES**

- 3.1. We will comply with the data protection law and principles when gathering and using personal information, as set out in our Data Protection Policy. This means that your data will be:
  - Used lawfully, fairly and in a transparent way.
  - Collected only for valid purposes that we have clearly explained to you and not used in a way that is incompatible with those purposes.
  - Relevant to the purposes we have told you about and limited only to those purposes.
  - Accurate and kept up to date.
  - Kept only as long as necessary for the purposes we have told you about.
  - Kept safely and securely.

#### **4. ABOUT THE INFORMATION WE COLLECT AND HOLD**

- 4.1. The table in Part 1 of the Schedule below summarises the information we collect and hold, up to and including the shortlisting stage of the recruitment process, how and why we do so, how we use it and with whom it may be shared.
- 4.2. The table in Part 2 of the Schedule below summarises the additional information we collect upon making a conditional offer, i.e. before making an offer of employment unconditional, how and why we do so, how we use it and with whom it may be shared.
- 4.3. We seek to ensure that our information collection and processing is always proportionate and necessary for specific legitimate purposes. We will notify you of any changes to information we collect or to the purposes for which we collect and process it.

#### **5. WHERE INFORMATION MAY BE HELD**

- 5.1. Information may be held on Groups premises in our filing systems and on our servers. It may also be held on our behalf by third party agencies, service providers and representatives.

#### **6. HOW LONG WE KEEP YOUR INFORMATION**

- 6.1. We keep the personal information that we obtain about you during the recruitment process for no longer than is necessary for the purposes for which it is processed. How long we keep your information will depend on whether your application, or the application you are supporting (e.g. as a referee) is successful and you (the job applicant) become employed by us, the nature of the information concerned and the purposes for which it is processed.
- 6.2. We will keep recruitment information (including interview notes) for no longer than is reasonable, taking into account the limitation periods for potential claims such as race or sex discrimination (as extended to take account of early conciliation), after which they will be destroyed. This is likely to be for one year from the communication of the outcome of the recruitment exercise which takes account of both the time limit to bring claims and for claims to be received by the Group. If there is a lawful reason for keeping recruitment records for longer than the recruitment period, we may do so but will first consider whether the records can be pseudonymised, and the longer period for which they will be kept.
- 6.3. If you are an applicant and your application is successful and you join the Group, we will keep only the recruitment information that is necessary in relation to your employment. For further information, see Privacy Notice for Staff.
- 6.4. If you are an applicant and you have consented for us to retain your personal information on file, on the basis that a further opportunity may arise in future and we will retain your personal information for a period of one year on this basis.
- 6.5. Further details on our approach to information retention and destruction are available in our information retention policy.

## **7. YOUR DATA RIGHTS TO CORRECT AND ACCESS YOUR INFORMATION AND TO ASK FOR IT TO BE ERASED**

- 7.1. Please contact the DPO if you would like to correct or request access to information that we hold relating to you or if you have any questions about this notice. You also have other rights including the right to ask for information we hold and process to be erased ('the right to be forgotten') or not used in certain circumstances. The DPOe will provide you with further information about your data rights, if you ask for it. You may also want to read the Privacy Notice for Staff which provides more detail on this.

## **8. KEEPING YOUR PERSONAL INFORMATION SECURE**

- 8.1. We have appropriate security measures in place to prevent personal information from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. This includes personal information being locked away, password protected or encrypted. We limit access to your personal information to those who have a genuine need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.
- 8.2. We also have procedures in place to deal with any suspected personal data breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

## **9. HOW TO COMPLAIN**

- 9.1. The DPO oversees compliance with this privacy notice and will respond to any query or concern you raise about our use of your information.
