<b>Purpose of Job</b>	
<p>The purpose of the job is to effectively clean the areas of the school, as allocated by the Cleaning Supervisor. Use cleaning materials, in accordance with the product instructions, as instructed by the Cleaning Supervisor and operate cleaning machinery, such as vacuum cleaners and floor polishers, in accordance with instructions.</p>

<ul style="list-style-type: none"> <li>• Vacuum-cleaning hard and soft floors.</li> <li>• Identifying cleaning spillages.</li> <li>• Wiping furniture, ledges, paintwork and doors and polishing door glass.</li> <li>• Emptying and cleaning bins and removing waste to the collection point.</li> <li>• Cleaning toilets and sanitary fittings and surrounds.</li> <li>• Mopping and spray cleaning hard floor surfaces.</li> <li>• Removal &amp; re-application of polish or varnish from hard indoor surfaces (after specific training &amp; competence assessment).</li> <li>• Wiping, polishing and straightening furniture.</li> <li>• Replenishing supplies in toilets.</li> <li>• Checking and closing windows.</li> <li>• Switching lights off after work (reporting any computers that do not automatically switch off at 7pm).</li> <li>• Reporting defects and hazards to the Cleaning Supervisor.</li> <li>• Undertaking routine cleaning tasks as directed when the school is closed, for example stripping and sealing floors, washing walls, furniture etc.</li> <li>• Diluting and using cleaning materials as directed.</li> <li>• Cleaning and maintaining cleaning equipment as instructed.</li> </ul>

<ul style="list-style-type: none"> <li>• Undertake any such duties commensurate with the post as directed by the Headteacher/Line Manager.</li> <li>• As part of the wider duties and responsibilities, the post holder is expected to promote and actively support the school's responsibilities towards safeguarding.</li> </ul>
